Applied Behavior Analysis, Graduate Certificate <u>ASU Online</u> Special Education (Applied Behavior Analysis), MA <u>ASU Online</u>

ASU's ABA programs include coursework that meets the Association for Behavior Analysis International verified course sequence requirements to qualify to sit for the Board Certified Behavior Analyst® (BCBA) exam. Applicants will need to meet additional requirements before they can be deemed eligible take the exam. We offer an optional practicum for students seeking to accrue BCBA supervised field experience.

The authority to practice applied behavior analysis, or use the title of behavior analyst, is granted on a state-by-state basis. Many states require BCBA certification for licensure. However, not all states have enacted legislation to create a regulatory body for ABA licensure and not all states that have licensure require BCBA certification. No Mary Lou Fulton Teachers College ABA program leads to teacher certification.

There is no governing body in place for the following states/jurisdictions: American Samoa, Arkansas, California, Colorado, Delaware, District of Columbia, Florida, Georgia, Guam, Idaho, Illinois, Indiana, Maine, Minnesota, Nebraska, New Hampshire, New Mexico, Northern Mariana Islands, Pennsylvania, Puerto Rico, South Carolina, U.S. Virgin Islands, West Virginia and Wyoming.

To apply via reciprocity, candidates must hold a comparable, standard and valid out of state educator license prior to applying for licensure – out of state license must have no pending/active deficiencies or disciplinary actions.

Alabama. If all other state credentialing requirements are met, a candidate may be granted a Class B (for Bachelor's level programs) or Class A (for Master's level programs) Educator Certificate (valid for 5 years). Please note: Alabama does not offer a Birth-Grade 3 certificate. A candidate may apply for a Birth-Age 4 or PreK-Grade 3 certificate.

Alaska. Candidates applying via reciprocity must have never held an Alaska teacher certificate. If all other state credentialing requirements are met, candidates applying directly may be issued an initial Two Year Teaching Certificate; or, if applying via reciprocity, may be granted an initial Out of State Certificate (valid for 1 year). To receive Alaska's Professional Teacher Certification, candidates must 1) meet all initial certificate requirements, 2) have two years of licensed teaching experience, 3) be currently employed in an Alaska public school district and 4) satisfy Alaska's mandatory trainings.

Arkansas. If all other state credentialing requirements are met, including but not limited to coursework in Arkansas History and other professional development trainings, a candidate may be granted a Standard Educator License. Candidates who have **not** completed all of Arkansas Standard Educator License requirements may be issued a

Provisional Educator License. <u>Please note, Arkansas does **not** offer the Birth-Grade 3 subject area. Candidates seeking licensure in this subject area may obtain an Early Childhood PreK-4 License.</u>

California. If all other state credentialing requirements are met, candidates may be granted a Preliminary Teaching Credential (valid for 5 years – nonrenewable). To receive a Clear Teaching Credential (valid for 5 years – nonrenewable), the candidate will need to 1) meet all preliminary credentialing requirements; 2) complete a two-year, job embedded, Teacher Induction Program; and 3) earn an English learning authorization (ASU's Structured English Immersion (SEI) endorsement is not an acceptable CA equivalent). Please note, California does not offer a Birth-Grade 3 subject area. Candidates seeking licensure in this subject area may apply for a Child Development Permit (allowing candidates to teach in programs like Head Start) or a Multiple Subject Teaching Credential via Reciprocity (allowing candidates to teach in a self-contained classroom).

Colorado. If all other state credentialing requirements are met, a candidate may be granted an Initial License (valid for 3 years). To receive a Professional License (valid for 5 years), the candidate will need to 1) meet all Initial License requirements and 2) complete a Colorado Induction Program or have three years of full time teaching experience (with a valid and comparable out of state teaching license).

Connecticut. If all other state credentialing requirements are met, a candidate may be granted an Initial Educator License (valid for 3 years).

Delaware. If all other state credentialing requirements are met, a candidate may be granted an Initial License and Standard Certificate. <u>Please note: Delaware's Early Childhood license and certificate is Birth-Grade 2.</u> **District of Columbia.** If all other state credentialing requirements are met, a candidate may be granted a Standard Teacher Credential (valid for 4 years – renewable). <u>Please note: The District of Columbia does **not** offer an Early Childhood Birth – Grade 3 certificate, a candidate may apply for a PreK-Grade 3.</u>

Florida. If all other state credentialing requirements are met, including but not limited to Florida's licensure exams, a candidate may be granted a Temporary or Professional Certificate. <u>Please note: Florida does **not** offer a Birth-Grade 3 certificate, instead Florida has a Birth – Age 4 and an Age 3 – Grade 3 certificate. A candidate may apply for either certificate.</u>

Georgia. To apply directly, a candidate must satisfy Georgia Assessments for the Certification of Educators ® (GACE®). To apply via reciprocity, and if all other state credentialing requirements are met, 1) a candidate with less than three years of full time teaching experience may be granted an Induction Certificate, or 2) candidates with three years or more full time teaching experience may be granted a Professional Certificate. <u>Please note:</u> Candidates completing their student teaching requirements in a Georgia school district cannot apply via reciprocity. Also, Georgia does **not** offer an Early Childhood Birth – Grade 3 certificate. Instead, a candidate completing the MLFTC Early Childhood program may be issued an Elementary (P-5) certificate and a Birth-K Endorsement.

Hawaii. If all other state credentialing requirements are met, a candidate may be granted a Provisional License (valid for 3 years-nonrenewable). To receive a Standard License (valid for 5 years- renewable), a candidate will need to 1) meet all Provisional License requirements and, 2) have three years of full time, standard license, teaching experience in a preK-12 classroom within the last 5 years. <u>Please note: Hawaii does not offer an Early Childhood Birth-Grade 3 certificate, instead a candidate may apply for a PreK-3 License.</u>

Idaho. If all other state credentialing requirements are met, a candidate may be granted an Interim Instructional Certificate (valid for 3 years – nonrenewable). To receive a Standard Instructional Certificate (valid for 5 years – renewable), a candidate will need to 1) meet all interim certification requirements and 2) complete 2 specific classes (Idaho Comprehensive Literacy Course and Mathematical Thinking).

Illinois. If all other state credentialing requirements are met, a candidate may be granted a Professional Educator License (PEL). <u>Please note: Illinois does **not** offer a Birth-Grade 3 license, a candidate may apply for a Birth-Grade 2 license.</u>

Indiana. If all other state credentialing requirements are met, a candidate may be granted a Reciprocal License. Please note: Indiana does **not** offer an Early Childhood Birth-Grade 3 license; however, a candidate may apply for a PreK-Grade 3 license.

Kansas. If all other state credentialing requirements are met, a candidate may be granted an Initial Teaching License

Louisiana. If all other state credentialing requirements are met, a candidate may be granted a Level I Professional Certificate or an Out of State (OS) Certificate. <u>Please note: Louisiana does **not** offer an Early Childhood Birth-Grade 3 license</u>, a candidate may apply for a PreK-Grade 3 license.

Maryland. If all other state credentialing requirements are met, a candidate may be granted a Maryland Professional Eligibility Certificate (valid for 5 years). <u>Please note: Maryland does **not** offer a Birth-Grade 3 certificate</u>, a candidate may apply for a PreK-Grade 3 certificate.

Massachusetts. If all other state credentialing requirements are met, a candidate may be granted an Initial License (valid for 5 years). <u>Please note: Massachusetts does **not** offer a Birth-Grade 3 license, a candidate may apply for a PreK-Grade 2 license.</u>

Michigan. If all other state credentialing requirements are met, a candidate may apply for Standard Teaching Certificate (valid for 5 years-renewable) directly. Candidates completing MLFTC Early Childhood and Early Childhood Special Education, BAE may apply for an early childhood and special education endorsement (age 2

years 6 months to 5 years) or a PreK-3 endorsement. Candidates completing MLFTC Curriculum and Instruction (Early Childhood Education), MEd may apply for a PreK-3 endorsement.

Minnesota. If all other state credentialing requirements are met, a candidate may be granted a Tier 3 License (valid for 3 years). Please note: Minnesota's Early Childhood Special Education is Birth-Age 6. Also, Minnesota requires candidates to have multiple student teaching placements. Candidates in Early Childhood are required to have experience at three levels: infant/toddler, preschool and K-Grade 3. Candidates who do not have multiple grade level placements may be restricted to the grade levels of completed student teaching experience.

Mississippi. If all other state credentialing requirements are met, candidates who have completed a MLFTC bachelor's –level program may be granted a Class A Educator License. Candidates who have completed a MLFTC master's-level program may be granted a Class AA Educator License. Please note: Mississippi does not offer an Early Childhood, Birth-Grade 3 or an Early Childhood, Special Education Birth-Grade 3 certificate.

Missouri. If all other state credentialing requirements are met, a candidate may be granted an Initial Professional Certificate.

Nebraska. If a candidate meets all other state credentialing requirements, including Nebraska's human relations training and special education training requirements, a candidate may be issued an Initial Teaching License. To receive a Standard Teaching License, a candidate will need to 1) meet all Initial Teaching License requirements, and 2) have two years of full time, standard license, teaching experience in a comparable grade/subject area. **Nevada.** To receive a Standard Teaching License, a candidate will need to 1) meet all Provisional Teaching License state credentialing requirements, and 2) satisfy Nevada-specific additional coursework: Parental Involvement and Family Engagement, Multicultural Education and Special Education, and 3) satisfy all exam(s)/assessment(s) requirement(s). Please note: Nevada does **not** offer a Birth-Grade 3 certificate, candidates may apply for Birth-Grade 2 certificate.

New Jersey. If all other state credentialing requirements are met, a candidate may apply for a Certificate of Eligibility with Advanced Standing (CEAS). To apply for a Standard Certificate, a candidate must 1) meet all CEAS requirements, 2) have two years of consecutive fulltime experience, and 3) have a valid out of state standard educator credential. Please note: New Jersey does **not** offer an Early Childhood, Birth-Grade 3 certificate. A candidate may apply for a PreK-Grade 3 certificate.

New Mexico. If all other state credentialing requirements are met, including one year of full time teaching experience AND one of the following: 1) 24 credits in core content area OR 2) passing content/subject area exams, the candidate may be granted a Level 1 teaching license. <u>Please note: New Mexico does **not** offer an Early Childhood, Birth-Grade 3 or an Early Childhood, Special Education Birth-Grade 3 educator license. A candidate may apply for either an Early Childhood, PreK-Grade 3 license or a Special Education, PreK-12 license. **North Carolina.** If all other state credentialing requirements are met, a candidate may apply for Initial Professional License (IPL) (valid for 3 years – nonrenewable). To receive a Continuing Professional License (CPL) (valid for 5 years renewable) the candidate will need to 1) meet all IPL requirements; 2) have a valid and comparable out of state license; and 3) have three years of full time teaching experience. <u>Please note: North Carolina does **not** offer a Birth-Grade 3 license. A candidate may apply for North Carolina Grades K-6 license.</u></u>

North Dakota. If all other state credentialing requirements are met, a candidate may be granted an Other State Educator License (OSEL).

Ohio. If all other state credentialing requirements are met, candidates completing a MLFTC program may be issued a Resident Educator License with limitations via reciprocity. To apply via reciprocity, a candidate must hold a comparable, standard and valid out of state license prior to applying for Ohio licensure. Please note: Candidates must satisfy all other Ohio state requirements, including an additional 6 credit hours in phonics and reading. Also, Ohio does **not** have a Birth-Grade 3 certificate. Candidates may be granted a PreK-Grade 3.

Oklahoma. If all other state credentialing requirements are met, a candidate may be granted a Standard Teaching Certificate. Please note: Oklahoma does **not** offer a Birth-Grade 3 certificate. A candidate may apply for a PreK-Grade 3 certificate.

Oregon. Please note: Oregon does not offer an equivalent Early Childhood educator certificate. A candidate may be granted a Reciprocal Teaching license with the Elementary Multiple Subject Endorsement. Candidates will have one year to successfully complete the ORELA Elementary Subtests I & II to be awarded a Preliminary or Professional Teaching License. Oregon does not offer an educator certificate in the following Special Education areas: Early Childhood and Mild/Moderate Disabilities. Candidates may apply for Oregon Special Education Generalist (PreK-Grade 12) endorsement after satisfying the appropriate Oregon exam.

Pennsylvania. If all other state credentialing requirements are met, a candidate may be granted an Instructional Level I certificate (valid for 6 years). To receive an Instructional Level II certificate (valid for 99 years), a candidate will need to 1) meet all Level I certificate requirements; 2) have three years of full time teaching experience in Pennsylvania; 3) complete a Pennsylvania Induction Program; and 4) have 24 post-baccalaureate credits. Please note: Pennsylvania does **not** offer an Early Childhood, Birth-Grade 3 certificate. A candidate may apply for PreK-Grade 4 certificate.

Rhode Island. If all other state credentialing requirements are met, a candidate may be granted an Initial Educator Certificate. To receive a Professional Educator Certificate, a candidate will need to: 1) meet all Initial Educator certification requirements; 2) have three years of full time teaching experience in Rhode Island; 3) complete an

appropriate number of professional learning units. <u>Please note: Rhode Island does **not** offer an Early Childhood, Birth-Grade 3 certificate. A candidate may apply for a PreK-Grade 2 certificate.</u>

South Carolina. Candidates completing a Traditional Teacher Preparation may apply for licensure directly or via reciprocity. To apply via reciprocity, a candidate must hold a comparable, standard and valid out of state license prior to applying for South Carolina licensure – out of state license with a US/AZ Constitution deficiency may be accepted. Please note: South Carolina does **not** offer an Early Childhood, Birth-Grade 3 certificate or an Early Childhood Special Education, Birth-Grade 3 certificate. A candidate may apply for an Early Childhood, PreK-Grade 3 certificate or a Special Education Ages 3-5. Educators are ineligible to apply for reciprocity if they hold a current South Carolina educator certificate or held a South Carolina Professional Certificate within the past 10 school years.

South Dakota. If all other state credentialing requirements are met, a candidate may be granted a Provisional Certificate.

Tennessee. If all other state credentialing requirements are met, a candidate may be granted a Practitioner License (valid for 3 years). Texas. If all other state credentialing requirements are met, a candidate may be granted a Standard Classroom Teacher Certificate (valid 5 years-renewable). <u>Please note: Texas does **not** offer an Early Childhood Education, Birth-Grade 3 certificate. A candidate may apply for PreK-Grade 3 certificate.</u>

Utah. Alabama. If all other state credentialing requirements are met, including but not limited to having three years of PreK-12 teaching experience, a candidate may be granted a Class A Instructional Leader Certificate (valid for 5 years).

Alaska. A candidate completing the MLFTC program may apply for licensure in Alaska via reciprocity. To apply via reciprocity, a candidate must hold a comparable, standard and valid out of state educator license prior to applying for Alaska licensure –out of state license must have no deficiencies or disciplinary actions. Additionally, a candidate must have never held an Alaska teacher certificate. If all other state credentialing requirements are met, an applicant may be granted an Initial 2 Year Administrator Certificate (valid for 2 years – nonrenewable). **Arkansas.** If all other state credentialing requirements are met, candidates may be granted a School Building Level Administrator Endorsement. <u>Please note: Arkansas educators must meet all in state requirements, including but not limited to, completing practicum experiences in both K-6 and 7-12 grade levels.</u>

California. If all other state credentialing requirements are met, including but not limited to having 5 years of full-time teaching experience, a candidate may be granted a Preliminary Administrative Services Credential (valid for 5

years – nonrenewable). To receive a Clear Administrative Services Credential (valid for 5 years – renewable), a candidate will need to 1) meet all preliminary credentialing requirements and 2) complete a two-year, job embedded, Administrative Services Clear Induction Program.

Delaware. If all other state credentialing requirements are met, the candidate may be granted an Initial License and Standard Principal Certificate.

Florida. If all other state credentialing requirements are met, including but not limited to Florida Licensure exam(s), a candidate may be granted an Educational Leadership Certificate. To progress to a School Principal Certificate, a candidate will need to 1) meet all Educational Leader Certificate requirements; 2) hold a Florida Educational Leadership Certificate and 3) successfully complete a FLDOE – approved, job embedded, Principalship Program. If all other state credentialing requirements are met, including 4 years of K-12 professional work experience, a candidate may be granted an Interim Instructional Certificate (valid for 3 years – nonrenewable). To receive a Standard Instructional Certificate (valid for 5 years – renewable), a candidate must 1) meet all interim certification requirements and 2) complete 1 specific class (Idaho Mathematical Thinking).

Illinois. A candidate completing the MLFTC program of study may apply for licensure in Illinois directly or via reciprocity. To apply via reciprocity, a candidate must hold a comparable, standard and valid out of state license prior to applying for Illinois licensure – out of state license must have no deficiencies. If all other state credentialing requirements are met, including but not limited to having four years of full-time teaching experience, a candidate may be granted a Principal License.

Indiana. A candidate completing the MLFTC program of study may apply for licensure in Indiana directly. If all other state credentialing requirements are met, including but not limited to CPR certification and Suicide Prevention training, a candidate may be granted a Building Level Administrator license.

Kansas. A candidate completing the MLFTC program of study may apply for licensure in Kansas via reciprocity. To apply via reciprocity, a candidate must hold a comparable, standard valid out of state license prior to applying for Kansas licensure – out of state license must have no deficiencies. If all other state credentialing requirements

are met, including five years of K-12 licensed teaching experience, a candidate may be granted an Initial School Leadership License.

Louisiana. A candidate completing the MLFTC program of study may apply for licensure in Louisiana directly. If all other state credentialing requirements are met, a candidate may be granted an Educational Leader Level I Certificate – EDL 1 (valid for 3 years).

Maryland. A candidate completing the MLFTC program of study may apply for licensure in Maryland directly. If all other state credentialing requirements are met, a candidate may be granted a Maryland Administrator I Certification (valid for 5 years).

Massachusetts. A candidate completing the MLFTC program of study may apply for licensure in Massachusetts directly. If all other state credentialing requirements are met, a candidate may be granted an Initial License (valid for 5 years).

Michigan. A candidate completing the MLFTC program of study may apply for licensure in Michigan directly. If all other state credentialing requirements are met, a candidate may apply for their Administrator License (valid for 5 years – renewable).

Missouri. A candidate completing the MLFTC program of study may apply for licensure in Missouri via reciprocity. To apply via reciprocity, candidates must hold a comparable, standard and valid out of state license prior to applying for Missouri licensure. If all other state credentialing requirements are met, a candidate may be granted an Initial Administrator Certificate.

Nevada. A candidate completing the MLFTC program of study may apply for licensure in Nevada directly. If all other state credentialing requirements are met, including but not limited to having five years of licensed full-time teaching experience, a candidate may be granted a Provisional Administrator License. To receive a Standard Administrator License, a candidate must 1) meet all Provisional Administrator License requirements; 2) satisfy the state's additional coursework: Parental Involvement and Family Engagement, Multicultural Education and Special Education; and 3) satisfy all exam(s)/assessment(s) requirement(s).

New Jersey. A candidate completing the MLFTC program of study may apply for licensure in New Jersey via reciprocity. If all other state credentialing requirements are met, including but not limited to having five years of full time teaching experience, a candidate may be granted a New Jersey Principal Certificate.

New Mexico. A candidate completing the MLFTC program of study may apply for licensure in New Mexico directly or via reciprocity. To apply via reciprocity, a candidate must hold a comparable, standard and valid out of state license prior to applying for New Mexico license – out of state license must have no deficiencies. If all other state credentialing requirements are met, a candidate may be granted an Educational Administration license.

North Carolina. A candidate completing the MLFTC program of study may apply for licensure in North Carolina directly. If all other state credentialing requirements are met, a candidate may apply for the Continuing School Administrator Principal License.

North Dakota. A candidate completing the MLFTC program of study may apply for licensure in North Dakota directly. If all other state credentialing requirements are met, a candidate may apply for their Level 1 Professional Principal Credential.

Ohio. A candidate completing the MLFTC program of study may apply for licensure in Ohio directly. If all other state credentialing requirements are met, a candidate may apply for the Administrator License.

Pennsylvania. A candidate completing the MLFTC program of study may apply for licensure in Pennsylvania. If all other state credentialing requirements are met, including but not limited to satisfying US and Wyoming Constitution coursework, a candidate may be granted an Initial Educator License with an Administrator Endorsement.

Alabama. If all other state credentialing requirements are met, a candidate may be granted a Class B (for Bachelor's level programs) Educator Certificate (valid for 5 years).

Alaska. Candidates applying via reciprocity must have never held an Alaska teacher certificate. If all other state credentialing requirements are met, candidates applying directly may be issued an initial Two Year Teaching Certificate; or, if applying via reciprocity, may be granted an initial Out of State Certificate (valid for 1 year). To receive Alaska's Professional Teacher Certification, candidates must 1) meet all initial certificate requirements, 2) have two years of licensed teaching experience, 3) be currently employed in an Alaska public school district and 4) satisfy Alaska's mandatory trainings.

To receive a Standard License (valid for 5 years- renewable), a candidate will need to 1) meet all Provisional License requirements and, 2) have three years of full time, standard license, teaching experience in a preK-12 classroom within the last 5 years.

Idaho. If all other state credentialing requirements are met, a candidate may be granted an Interim Instructional Certificate (valid for 3 years – nonrenewable). To receive a Standard Instructional Certificate (valid for 5 years – renewable), a candidate must 1) meet all interim certification requirements and 2) complete two specific classes (Idaho Comprehensive Literacy Courses and Mathematical Thinking).

Indiana. If all other state credentialing requirements are met, a candidate may be granted a Reciprocal License. *Kansas.* If all other state credentialing requirements are met, a candidate may be granted an Initial Teaching License.

To receive a Standard Teaching License, a candidate will need to 1) meet all Initial Teaching License requirements,

and 2) have two years of full time, standard license, teaching experience in a comparable grade/subject area. **Nevada.** A candidate completing the program may apply for the Nevada Provisional Teaching License via reciprocity. To receive a Standard Teaching License, a candidate will need to 1) meet all Provisional Teaching License requirements, 2) satisfy Nevada-specific additional coursework: Parental Involvement and Family Engagement, Multicultural Education and Special Education, and 3) satisfy all exam(s)/assessment(s) requirement(s).

New Jersey. If all other state credentialing requirements are met, a candidate may apply for a Certificate of Eligibility with Advanced Standing (CEAS). Rhode Island. If all other state credentialing requirements are met, a candidate may be granted an Initial Educator Certificate. To apply for a Standard Certificate, a candidate must 1) meet all CEAS requirements, 2) have two years of consecutive fulltime experience, and 3) have a valid out of state standard educator credential.

Vermont. If all other state credentialing requirements are met, a candidate may be granted a Level I License (valid for 3 years). Please note: A candidate with Grades PreK-12 certificates or endorsements, who does **not** have experiential experience in both elementary and secondary grade levels may be issued a license with grade level limits.

A candidate in Elementary Education programs is required to have placement at the preliminary and intermediate elementary levels. Middle school candidates are required to have placements in grades levels: K-6, 5-8 and 9-12. Candidates without multiple grade level placements may be restricted to teaching in the grade level(s) with accompanying student teacher experience. For example, an Elementary Education candidate with student teaching experience in only grades 4-6 and no experience in grades K-3 will be restricted to teaching only Grades 4-6.

Mississippi. If all other state credentialing requirements are met, a candidate who has completed a MLFTC master-level program may be granted a Class AA Educator License.

Missouri. If all other state credentialing requirements are met, a candidate may be granted an Initial Professional Certificate

Nebraska. If a candidate has met all other state credentialing requirements, including Nebraska's human relations training and special education training requirements, a candidate may be issued an Initial Teaching License. To receive a Standard Teaching License a candidate will need to 1) meet all Initial Teaching License requirements, and 2) have two years of full time, standard license, teaching experience in a comparable grade/subject area.

Nevada. A candidate completing a MLFTC program may apply for the Nevada Provisional Teaching License via reciprocity. To receive a Standard Teaching License, a candidate must 1) meet all Provisional Teaching License requirements, 2) satisfy Nevada-specific additional coursework: Parental Involvement and Family Engagement, Multicultural Education and Special Education, and 3) satisfy all exam(s) assessment(s) requirement(s).

New Jersey. If all other state credentialing requirements are met, a candidate may apply for a Certificate of Eligibility with Advanced Standing (CEAS). To apply for a Standard Certificate, a candidate must 1) meet all CEAS requirements, 2) have two years of consecutive fulltime experience, and 3) have a valid out of state standard educator credential.

New Mexico. If all other state credentialing requirements are met, including one year of full time teaching experience AND one of the following: 1) 24 credits in core content area OR 2) passing content/subject exams, a

candidate may be granted a Level 1 teaching license.

North Carolina. If all other state credentialing requirements are met, a candidate may apply for Initial Professional License (IPL) (valid for 3 years – nonrenewable). To receive a Continuing Professional License (CPL) (valid for 5 years – renewable) a candidate must 1) meet all IPL requirements, 2) have a valid and comparable out of state license, and 3) have three years of full time teaching experience.

North Dakota. If all other state credentialing requirements are met, a candidate may be granted an Other State Educator License (OSEL).

Ohio. If all other state credentialing requirements are met, a candidate completing a MLFTC program may be issued a Resident Educator License with limitations via reciprocity. To apply via reciprocity, a candidate must hold a comparable, standard and valid out of state license prior to applying for Ohio licensure. <u>Please note: A candidate must satisfy all other Ohio state requirements, including an additional 6 credit hours in phonics and reading.</u> **Oklahoma.** If all other state credentialing requirements are met, a candidate may be granted a Standard Teaching Certificate.

Oregon. A candidate completing the MLFTC program, who has never previously held an Oregon license or completed an Oregon based educator or administrator prep program, may apply for a Reciprocal License (valid for 1 year – nonrenewable) via reciprocity. To apply via reciprocity, a candidate must hold a comparable, standard and valid out of state license prior to applying for Oregon licensure – out of state license must have no deficiencies. A candidate seeking a Preliminary Teaching License (valid for 3 years – renewable) must meet all Reciprocal License requirements and satisfy Oregon's exam/assessment requirement(s).

Pennsylvania. If all other state credentialing requirements are met, a candidate may be granted an Instructional Level I certificate (valid for 6 years). To receive an Instructional Level II certificate (valid for 99 years), a candidate will need to 1) meet all Level I certificate requirements, 2) have three years of full time teaching experience in Pennsylvania, 3) complete a Pennsylvania Induction Program; and 4) have 24 post-baccalaureate credits. **Rhode Island.** If all other state credentialing requirements are met, a candidate may be granted an Initial Educator Certificate. To receive a Professional Educator Certificate, a candidate will need to: 1) meet all Initial Educator certification requirements, 2) have 3 years of full time teaching experience in Rhode Island, and 3) complete an appropriate number of professional learning units.

South Carolina. Candidates completing a Traditional Teacher Preparation Program may apply for licensure directly or via reciprocity. To apply via reciprocity, a candidate must hold a comparable, standard and valid out of state license prior to applying for South Carolina licensure – out of state license with a US/AZ Constitution deficiency may be accepted.

South Dakota. If all other state credentialing requirements are met, a candidate may be granted a Provisional Certificate.

Tennessee. If all other state credentialing requirements are met, a candidate may be granted a Practitioner License (valid for 6 years), a candidate must 1) meet all Practitioner License requirements, 2) have three years of full time licensed, teaching experience in grade/subject area, and 3) earned 30 professional development points. **Texas.** If all other state credentialing requirements are met, a candidate may be granted a Standard Classroom Teacher Certificate (valid for 5 years – renewable).

Utah. If all other state credentialing requirements for licensure are met, including but not limited to exam requirements, a candidate may be granted a Professional Educator license.

Vermont. If all other state credentialing requirements are met, a candidate may be granted a Level I License (valid for 3 years). Please note: A candidate with Grades PreK-12 certificates or endorsements, who does **not** have experiential experience in both elementary and secondary grade levels may be issued a license with grade level limits.

Virginia. If all other state credentialing requirements are met, including training in child abuse recognition and intervention, first aid/CPR, behavior intervention and dyslexia awareness, a candidate may be granted a Collegiate Professional License.

Washington. If all other state credentialing requirements are met, a candidate may be granted a Residency Certificate (First Issue). This certificate may progress to a Residency Certificate once a candidate has been employed as a teacher and has acquired 1.5 FTE status. To receive a Professional Certificate, a candidate must 1) meet all Residency Certificate requirements, 2) complete National Boards Certificate, and 3) complete an Issues of Abuse training course.

West Virginia. If all other state credentialing requirements are met, a candidate may be granted an Initial Professional Teacher Certificate.

Wisconsin. A candidate completing the MLFTC program may apply for licensure in Wisconsin via reciprocity. To apply via reciprocity, a candidate must possess a comparable standard and valid out of state license prior to applying for Wisconsin licensure. The out of state license must have no deficiencies. A candidate may be issued an initial teaching license if all other state credentialing requirements are met, including but not limited to satisfying US and Wyoming Constitutional coursework, the candidate may be granted an Initial Educator License.

If all other state credentialing requirements are met, a candidate applying directly may be issued an initial Two Year Teaching Certificate, or, if applying via reciprocity, may be granted an initial Out of State Certificate (valid for 1 year). To receive an Alaskan Professional Teacher Certification, a candidate must 1) meet all initial certificate requirements, 2) have two years of licensed teaching experience, 3) be currently employed in an Alaskan public school district, and 4) satisfy Alaskan mandatory training(s).

Arkansas. If all other state credentialing requirements are met, including but not limited to coursework in Arkansas History and other professional development trainings, a candidate may be granted a Standard Educator License. A candidate who has **not** completed all of the Arkansas Standard Educator License requirements may be issued a Provisional Educator License.

California. If all other state credentialing requirements are met, a candidate may be granted a Preliminary Teaching Credential (valid for 5 years – nonrenewable). To receive a Clear Teaching Credential (valid for 5 years – nonrenewable), a candidate must 1) meet all preliminary credentialing requirements, 2) complete a two year, job embedded, Teacher Induction Program, and 3) earn an English learning authorization (ASU's Structured English Immersion (SEI) endorsement is **not** an acceptable CA equivalent).

Colorado. If all other state credentialing requirements are met, a candidate may be granted an Initial License (valid for 3 years). To receive a Professional License (valid for 5 years), a candidate must 1) meet all Initial License requirements and 2) complete a Colorado Induction Program or have three years of full time teaching experience (with a valid and comparable out of state teaching license).

Connecticut. If all other state credentialing requirements are met, a candidate may be granted an Initial Educator License (valid for 3 years).

Delaware. If all other state credentialing requirements are met, a candidate may be granted an Initial License and Standard Certificate.

District of Columbia. If all other state credentialing requirements are met, a candidate may be granted a Standard Teacher Credential (valid for 4 years – renewable).

Florida. If all other state credentialing requirements are met, including but not limited to Florida's licensure exams, a candidate may be granted a Temporary or Professional Certificate.

Georgia. To apply directly, a candidate must satisfy Georgia Assessments for the Certification of Educators® (GACE®). To apply via reciprocity, and if all other state credentialing requirements are met, 1) a candidate with less than three years or more full time teaching experience may be granted an Induction Certificate, or 2) candidates with three years or more full time teaching experience may be granted a Professional Certificate. Please note: A candidate completing student teaching requirements in a Georgia school district **cannot** apply via reciprocity.

Hawaii. If all other state credentialing requirements are met, a candidate may be granted a Provisional License (valid for 3 years – nonrenewable). To receive a Standard License (valid for 5 years – renewable), a candidate must 1) meet all Provisional License requirements, and 2) have three years of full time, standard license, teaching

experience in a PreK-12 classroom within the last 5 years.

Idaho. If all other state credentialing requirements are met, a candidate may be granted an Interim Instructional Certificate (valid for 3 years – nonrenewable). To receive a Standard Instructional Certificate (valid for 5 years – renewable), a candidate must 1) meet all interim certification requirements and 2) complete two specific classes (Idaho Comprehensive Literacy Course and Mathematical Thinking).

Illinois. If all other state credentialing requirements are met, a candidate may be granted a Professional Educator License (PEL).

Indiana. If all other state credentialing requirements are met, a candidate may be granted a Reciprocal License. *Louisiana.* If all other state credentialing requirements are met, a candidate may be granted a Level I Professional Certificate or an Out of State (OS) Certificate.

Maryland. If all other state credentialing requirements are met, a candidate may be granted a Maryland Professional Eligibility Certificate (valid for 5 years).

Massachusetts. If all other state credentialing requirements are met, a candidate may be granted an Initial License (valid for 5 years).

Minnesota. If all other state credentialing requirements are met, including but not limited to exams and 12 weeks of student teaching, a candidate may be granted a Tier 3 License (valid for 3 years). To receive a Standard Teaching License, a candidate must 1) meet all Initial Teaching License requirements, and 2) have two years of full time, standard license, teaching experience in a comparable grade/subject area.

Nevada. Candidates must possess a Bachelor-level degree in the desired teaching subject (ex: Bachelor in Biology seeking Masters in Secondary Ed, Biology). If all other state credentialing requirements are met, a candidate who has a degree in the desired teaching subject and has completed MLFTC-ASU teacher certification program may apply for licensure in Nevada via reciprocity. A candidate applying via reciprocity must hold a comparable and valid out of state license prior to applying for Nevada licensure – out of state license must **not** have any deficiencies.

New Jersey. If all other state credentialing requirements are met, a candidate may apply for a Certificate of Eligibility with Advanced Standing (CEAS). To apply for a Standard Certificate, a candidate must 1) meet all CEAS requirements, 2) have two years of consecutive fulltime experience, and 3) have a valid out of state standard educator credential.

New Mexico. If all other state credentialing requirements are met, including one year of full time teaching experience AND one of the following: 1) 24-credit in core content area OR 2) passing content/subject area exams, a candidate may be granted a Level I teaching license.

North Carolina. If all other state credentialing requirements are met, a candidate may apply for Initial Professional License (IPL) (valid for 3 years – nonrenewable). To receive a Continuing Professional License (CPL) (valid for 5 years – renewable) the candidate must 1) meet all IPL requirements, 2) have a valid and comparable out of state license, and 3) have three years of full time teaching experience.

North Dakota. If all other state credentialing requirements are met, a candidate may be granted an Other State Educator License (OSEL).

Ohio. If all other state credentialing requirements are met, a candidate completing a MLFTC program may be issued a Resident Educator License with limitations via reciprocity. To apply via reciprocity, a candidate must hold a comparable, standard and valid out of state license prior to applying for Ohio licensure. <u>Please note: A candidate must satisfy all other Ohio state credentialing requirements, including an additional 6 credit hours in phonics and reading.</u>

Oregon. A candidate who has completed a MLFTC program, and has never previously held an Oregon license or completed an Oregon based educator or administrator prep program, may apply for a Reciprocal License (valid for 1 year – nonrenewable) via reciprocity. To apply via reciprocity, a candidate must hold a comparable, standard and valid out of state license prior to applying for Oregon licensure – out of state license must have no deficiencies. A candidate seeking a Preliminary Teaching License (valid for 3 years – renewable) must meet all Reciprocal License requirements and satisfy Oregon's exam/assessment requirement(s).

Pennsylvania. A candidate must have a Bachelor level degree in the desired teaching subject (ex: Bachelors in Biology seeking Masters in Secondary Ed. Biology). If all other state credentialing requirements are met, a candidate who has a degree within the desired teaching subject and has completed MLFTC-ASU teacher certification programs may apply for licensure in Pennsylvania directly.

Rhode Island. If all state credentialing requirements are met, a candidate may be granted an Initial Educator Certificate. To receive a Professional Educator Certificate, a candidate must 1) meet all Initial Educator certification requirements, 2) have three years of full time teaching experience in Rhode Island, and 3) complete an appropriate number of professional learning units.

South Carolina. A candidate completing a Traditional Teacher Preparation Program may apply for licensure directly or via reciprocity. To apply via reciprocity, a candidate must hold a comparable, standard and valid out of state license prior to applying for South Carolina licensure – out of state license with a US/AZ Constitution deficiency may be accepted.

South Dakota. If all other state credentialing requirements are met, a candidate may be granted a Provisional Certificate.

Tennessee. If all other state credentialing requirements are met, a candidate may be granted a Practitioner License (valid for 3 years). To receive a Professional License (valid for 6 years), a candidate must 1) meet all Practitioner License requirements, 2) have three years of full time, licensed, teaching experience in grade/subject area, and 3) earned 30 professional development points.

Texas. If all other state credentialing requirements are met, a candidate may be granted a Standard Classroom Teacher Certificate (valid for 5 years – renewable).

Vermont. If all other state credentialing requirements are met, a candidate may be granted a Level I License (valid for 3 years). Please note: A candidate with Grades Pre-K-12 certificates or endorsements, who does **not** have experiential experience in both elementary and secondary grade levels may be issued a license with grade level limits.

Virginia. If all other state credentialing requirements are met, including training in child abuse recognition and intervention, first aid/CPR, behavior intervention and dyslexia awareness, a candidate may be granted a Collegiate Professional License.

Washington. If all other state credentialing requirements are met, a candidate may be granted a Residency Certificate (First Issue). Hawaii. If all other state credentialing requirements are met, a candidate completing MLFTC program may apply for licensure in Hawaii directly.

Idaho. If all other state credentialing requirements are met, a candidate completing MLFTC program may apply for licensure in Idaho via reciprocity. To apply via reciprocity, a candidate must hold a comparable, standard and valid out-of-state license prior to applying for Idaho licensure. Out-of-state license must have no deficiencies.

Illinois. If all other state credentialing requirements are met, a candidate completing MLFTC program may apply for licensure in Illinois directly or via reciprocity. A candidate must hold a comparable, standard and valid out-of-state license prior to applying for Illinois licensure.

Indiana. If all other state credentialing requirements are met, a candidate completing the MLFTC program may apply for licensure in Indiana via reciprocity. To apply via reciprocity, a candidate must hold a comparable, standard and valid out-of-state license prior to applying for Indiana licensure. Out-of-state license must have no deficiencies or active/pending disciplinary actions.

Maryland. If all other state credentialing requirements are met, a candidate completing a MLFTC program may apply for licensure in Maryland directly.

Massachusetts. If all other state credentialing requirements are met, a candidate completing a MLFTC program may apply for licensure in Massachusetts directly.

Michigan. If all other state credentialing requirements are met, a candidate completing a MLFTC program may apply for licensure in Michigan directly.

Mississippi. If all other state credentialing requirements are met, a candidate completing a MLFTC program may apply for licensure in Mississippi via reciprocity. A candidate applying via reciprocity must hold a comparable and valid out-of-state license prior to applying for Mississippi licensure.

Nevada. If all other state credentialing requirements are met, a candidate completing a MLFTC program may

apply for licensure via reciprocity. To apply via reciprocity, a candidate must hold a comparable, standard and valid out-of-state license prior to applying for Nevada licensure. Out-of-state license must have no deficiencies.

New Mexico. If all other state credentialing requirements are met, a candidate completing a MLFTC program may apply for licensure in New Mexico via reciprocity. To apply via reciprocity, a candidate must hold a comparable, standard and valid out-of-state license prior to applying for New Mexico licensure. Out-of-state license must have no deficiencies

North Carolina. If all other state credentialing requirements are met, a candidate completing a MLFTC program may apply for licensure in North Carolina directly.

North Dakota. If all other state credentialing requirements are met, a candidate completing a MLFTC program may apply for licensure in North Dakota via reciprocity.

Oklahoma. If all other state credentialing requirements are met, a candidate completing a MLFTC program may apply for certification directly or via reciprocity. To apply via reciprocity, a candidate must hold a comparable, standard and valid out-of-state license prior to applying for Oklahoma certification.

Rhode Island. If all other state credentialing requirements are met, a candidate completing a MLFTC program may for licensure in Rhode Island directly.

South Carolina. If all other state credentialing requirements are met, a candidate completing a MLFTC program may apply for licensure directly. A candidate completing an Alternative Teacher Preparation may apply for licensure via reciprocity. To apply via reciprocity, a candidate must hold a comparable, standard and valid out-of-state license prior to applying for South Carolina licensure. Out-of-state license with a US/AZ Constitution deficiency may be accepted. Please note: Educators are **not** eligible to apply via reciprocity if they hold a current South Carolina educator certificate or held a Professional Certificate within the past 10 school years.

South Dakota. If all other state credentialing requirements ae met, a candidate completing a MLFTC program may apply for licensure in South Dakota via reciprocity. To apply via reciprocity, candidates must hold a comparable, standard and valid out-of-state license prior to applying for South Dakota licensure. Out-of-state license must have no deficiencies.

Vermont. If all other state credentialing requirements are met, a candidate completing a MLFTC program may apply for licensure in Vermont directly. <u>Please note: A candidate with Grades PreK-12 certificates or endorsements</u>, who does **not** have experiential experience in both elementary and secondary grade levels, may be issued a license with grade level limits.

West Virginia. If all other state credentialing requirements are met, a candidate completing a MLFTC program may apply for certification in West Virginia directly or via reciprocity. To apply via reciprocity, a candidate must hold a comparable, standard and valid out of state license prior to applying for West Virginia licensure.

Wisconsin. A candidate completing the MLFTC program may apply for licensure in Wisconsin via reciprocity. To apply via reciprocity, candidates must possess a comparable standard and valid out-of-state license prior to applying for Wisconsin licensure. The out-of-state license must have no deficiencies. A candidate may be issued an initial teaching license if all other state credentialing requirements are met, including one year of full time teaching experience.

Wyoming. If all other state credentialing requirements are met, a candidate completing a MLFTC program may apply for licensure in Wyoming directly.
